Camp Buckeye 2009: *Transportation Form*

Dear Parents, Campers and Staff,

In order to ensure the safe, orderly and authorized arrival and departure of all campers and staff to and from Camp Buckeye, we are asking that campers, parents and staff read and follow the procedures and rules listed below. Please then fill out and sign the information and authorization form below, and send it back to the address below no later than **June 15, 2009**.

Arrival – Camp Buckeye policy specifies that vehicles must, upon arrival and departure, park in the main parking area in front of the ball field and registration area. Signs will be posted on site identifying this location for check-in. Vehicular traffic in other parts of camp is prohibited, except for the site managers. Please arrive between **3 p.m. and 5 p.m.**, Sunday, July 26. Early arrivals **cannot** be accommodated since all our staff will be involved in final training and preparations.

Registration – Campers will generally be registered by a parent, guardian, driver, or other responsible party who has been authorized by the parents or legal guardians of the child. Then campers will go to the nurse's station for medical screening and finally be escorted by a staff member to their quarters. Although the registration process may vary slightly depending on the camp, UYC assumes supervisory responsibility for campers *when registration is complete*. UYC relinquishes responsibility when the camper is signed out at the end of camp.

Changes – If your plans change after you send in this form, please call Mr. Dave Myers at (330) 686-5881 to inform him of any changes or cancellations.

- **Departure** – Please pick up your camper(s) at 6 p.m. on Wednesday, July 29, 2009.
